MINUTES OF THE LA PAZ COUNTY BOARD OF SUPERVISORS Monday, March18, 2019, 10:00 a.m. Regular Meeting

Chairman Minor called the March 18, 2019, regular meeting of the La Paz County Board of Supervisors to order at 10:00 a.m. Elected Officials and Department Heads present were: Chairman Minor, Supervisor Irwin, Supervisor Wilson, County Administrator Drake, Deputy County Attorney Dooley, Finance Director Krukemyer, Human Resource Director Frantz, Elections Director Scholl, Sheriff Risen, Community Development Director McCormick, School Superintendent Price, Assessor Camacho, Recorder Baker and Clerk of the Board Green.

Chairman Minor led the Pledge of Allegiance followed by the Invocation given by Pastor Julian Barbara of the Calvary Christian Fellowship.

Presentation: "Sandy Dodge Employee Excellence" award

This item was moved down the agenda.

Call to the Public: This is the time for the public to comment for a limit of three (3) minutes per person. Members of the Board may not discuss items that are not specifically identified on the agenda. Therefore, pursuant to A.R.S. § 38-431.01(H), action taken as a result of public comment will be limited to directing staff to study the matter, responding to any criticism or scheduling the matter for further consideration and decision at a later date

Sheriff Risen announced that the Arizona Department of Transportation (ADOT) presence will be on Highway 60 and Hwy 72 for truck weight enforcement.

County Administrator and/or County Supervisor's Current Event Summary: The County Administrator or Board Member may present a brief summary of current events summarizing recent occurrences without any discussion or feedback from the remainder of the board. The Board will not propose, discuss, deliberate or take legal action on any matter mentioned in the summary unless the specific matter is already properly noticed for legal action, and then only at such time as that matter comes before the board itself pursuant to its meeting agenda. Chairman Minor shared the news relating to the County's land conveyance of approximately 6,000 acres, a bill just signed by President Trump.

Supervisor Irwin stated that she had received a call from the Army Corps of Engineers informing her of the onset of water releases, adding that the releases will be watched closely in view of the frequent rainfall in the area.

She further added that HB2467, relating to the formation of a water advisory council, had passed through the House and would now be heard in a Senate hearing, which she would be attending.

Supervisor Irwin stated that the controversial Harquahala Basin bill (HB2609) continues to be a "fight" with legislators relating to taking water out of the County for "personal gain".

Arizona Department of Revenue Application for Bingo License submitted by Theodora Grayson, Brenda Gutierrez, and James Esten for bingo activities located at Black Rock RV Village, 46751 E. Highway 60, in Salome – Clerk of the Board

Clerk of the Board Green stated that the application for a bingo license required a public hearing to receive any comments from the public regarding the application for bingo activities, which would occur at the Black Rock RV Village, 46751 E. Highway 60, in Salome, scheduled for 6:30 p.m. on Saturdays. She added that no games would occur from the 3rd week in April through the first week in November.

Chairman Minor opened the public hearing and asked if anyone wished to comment on the application for a Bingo License.

There being no comment, Chairman Minor closed the public hearing.

Chairman Minor asked if a bingo license required the same kind of posting as required by a liquor license.

Clerk of the Board Green answered that a bingo license application did not require the same kind of posting; however, it did require a public hearing conducted by the Board and noticed with the regular posting of the agenda.

Approve payment to Cunningham Users Association as the La Paz County Sheriff's Office portion to repair the road to the top of Cunningham Mountain – Sheriff

Lieutenant Epps presented for approval an invoice from Cunningham Users Association in the amount of \$14,883, a portioned amount the Sheriff's Department, as one of the 12 users of the communication tower located on the top of Cunningham Mountain, was billed to pay as part of the \$175,000 total cost to repair the road.

He added that the Sheriff's Department is not the only user of the tower, noting that Public Works and 9-1-1 Dispatch depend on that communication and it would cause "a huge hole" in communications not to be part of the user's group. He further added that he was not aware that the bill would be coming forward.

Discussion ensued as to whether there was ever a formal agreement approved by the Board; what kind of Board action was taken in the past, and speculation on the ownership of the mountain, noting that the road to the top of the mountain was known to be in extremely bad condition.

Chairman Minor recommended continuing the item to the next regular Board meeting for additional information.

SUPERVISOR WILSON MOVED to continue "Approve payment to Cunningham Users Association as the La Paz County Sheriff's Office portion to repair the road to the top of Cunningham Mountain' to the next regular meeting on April 1, 2019. Motion seconded by Supervisor Irwin, passed unanimously, including the vote by Chairman Minor.

Gary Drummond, legal counsel representing the Industrial Development Authority (IDA), stated that the IDA had given final approval for revenue bonds in favor of the SSS Education Foundation – Pioneer Technology & Arts Academy Project, a \$78 million bond issue with a two-stage bond process.

He explained that the IDA had issued bonds previously, similar to this one, acquiring closing fees and administration fees in each instance; the funds utilized for community development in La Paz County. He further explained that there was no liability to the County or the IDA for these proceedings, and needed only the approval of the governing body, that being the Board of Supervisors.

SUPERVISOR WILSON MOVED to adopt Resolution No. 2019-05, approving the proceedings of the Industrial Development Authority of the County of La Paz, Arizona relative to the issuance by The Industrial Development Authority of the County of La Paz, Arizona of its taxable education facility lease revenue bonds in an aggregate principal amount not to exceed \$11,000,000 for SSS Education Foundation – Pioneer Technology & Arts Academy Project. Motion seconded by Supervisor Irwin, passed unanimously, including the vote by Chairman Minor.
