PRIMARY ELECTION

August 2, 2022
(Registration closes July 5, 2022)

GENERAL ELECTION

November 8, 2022
(Registration closes October 11, 2022)

DATE FOR FILING CANDIDATE NOMINATION PAPERS

First Date to File	March 7, 2022 (150 days prior to election)
Last Date to File, 5:00 p.m.	April 4, 2022 (120 days prior to election)

Required documents:

1. You must file a **“Statement of Interest”** before you can begin to collect signatures. (Precinct Committeeman Candidates DO not file a Statement of Interest)
2. Nomination Paper, Affidavit of Qualifications, Campaign Finance Law (three forms in one)
3. Personal Financial Disclosure Statement
4. Nomination Petitions containing minimum number of signatures.

****If during your campaign you have expenditures or receive contributions (in any combination) in the amount of \$1,300, you must form a committee, and file a Statement of Organization with ten (10) days of reaching that threshold. You will also be required to file a “Termination Statement” after the election.**

County (no later than) August 12, 2022
State (no later than) August 15, 2022

GENERAL CANVASS

County (no later than) November 28, 2022
State (no later than) December 5, 2022
