MINUTES OF THE LA PAZ COUNTY BOARD OF SUPERVISORS Monday, February 7, 2022, 10:00 a.m. Regular Meeting

Chairman Minor called the February 7, 2022, regular meeting of the La Paz County Board of Supervisors to order at 10:00 a.m. Elected Officials and Department Heads present were: Chairman Duce Minor, Vice-Chairman Holly Irwin, Supervisor David Plunkett, County Administrator Megan Spielman, Chief Deputy County Attorney Ryan Dooley, Assessor Anna Camacho, IT Tech Joey Lucas, Parks Director Curt Bagby, Superior Court Clerk Holly Lucas, Public Works Director Don Braska and Clerk of the Board Diane Green.

Chairman Minor led the Pledge of Allegiance followed by the Invocation given by Pastor Jose Garcia of the Parker Apostolic Church.

Call to the Public: This is the time for the public to comment for a limit of three (3) minutes per person. Members of the Board may not discuss items that are not specifically identified on the agenda. Therefore, pursuant to A.R.S. § 38-431.01(H), action taken as a result of public comment will be limited to directing staff to study the matter, responding to any criticism or scheduling the matter for further consideration and decision at a later date

Judi May requested that, since the approval to consolidate the justice courts, that the one court in La Paz should be located in Quartzsite.

Melissa Newton, with the Parker Regional Chamber of Commerce and Tourism, stated that La Paz County is very much represented by ads taken out in the Arizona Official State Travel Guide. She noted a number of activities that will be occurring in the coming months. She is looking forward to getting Parker certified as an Arizona Office of Tourism Visitor Center.

County Administrator Spielman stated that since the County has approved consolidating the justice courts, she is working closely with presiding Judge Quickle, town managers, the magistrate judges, the supreme court and one justice court judge in Santa Cruz County that absorbed a court, to map out next steps. She has several meetings set up for guidance.

VICE-CHAIRMAN IRWIN MOVED to approve Consent Agenda Items #5(a) through #5(m). Motion seconded by Supervisor Plunkett, passed unanimously, including the vote by Chairman Minor.

REGULAR AGENDA (Discussion and possible action on the following items):

Discussion and possible action to adopt Resolution No. 2022-02, to support the application to the Arizona State Board on Geographic and Historical Names to name Interstate 10 from Mile Marker 71 to the Arizona/California border "La Paz County Sheriff's Sergeant Michael Rudd Memorial Highway" - Board of Supervisors

Chairman Minor stated, in view of the loss of Sergeant Rudd in October, he felt it appropriate to submit an application for the naming of Interstate 10 from Mile Marker 71 to the Arizona/California border "La Paz County Sheriff's Sergeant Michael Rudd Memorial Highway" along with a resolution for the Board to adopt for this action.

He read the resolution in its entirety, adding that Mrs. Rudd was supportive and appreciative of the proposal.

SUPERVISOR PLUNKETT MOVED to adopt Resolution No. 2022-02, to support the application to the Arizona State Board on Geographic and Historical Names to name Interstate 10 from Mile Marker 71 to the Arizona/California border "La Paz County Sheriff's Sergeant Michael Rudd Memorial Highway". Motion seconded by Vice-Chairman Irwin, passed unanimously, including the vote by Chairman Minor.

Discussion and possible action to approve a three-year contract with Frontier to install broadband internet at La Paz County Park (Upriver) and to provide internet service - *Parks*

Parks Director Bagby requested approval of a service contract with Frontier to install broadband internet for the purpose of providing wifi service to guests in the Park as well as bring them up to date with better technology in the operation of the parks.

He explained that it would run \$1,900 per month for the service and he is having a

trench dug for the installation of the fiber at a "good cost", which will ultimately be a cheaper and a more reliable form of wifi. He added that Frontier assured him that one "gig" of broadband would be adequate to service all the park's needs.

Discussion ensued, noting that, although this item is not a budgeted item, the park is classified as an "enterprise" and generates its own revenues for its operations at approximately \$300,000 annually, and is not general fund dependent.

Further discussion ensued concerning the need to increase rates, which has not been done in a considerable amount of time, particularly in view of the improvements that have been made in the past year and will be made in the coming months.

VICE-CHAIRMAN IRWIN MOVED to approve a three-year contract with Frontier to install broadband internet at La Paz County Park (Upriver) and to provide internet service, authorizing the Chairman or his designee to sign. Motion seconded by Chairman Minor, passed unanimously, including the vote by Supervisor Plunkett.

Discussion and possible action for the La Paz County Board of Supervisors to take an official position and to provide comments regarding the Western Area Power Administration (WAPA) Draft Environmental Assessment for the Bouse Upgrade Project - Board of Supervisors

Chairman Minor explained that the Western Area Power Administration (WAPA) was accepting comments regarding their proposal regarding their Bouse Upgrade Project. He stated that the WAPA poles have substantially outlived their life expectancy and when they offered a plan to replace them, he was not happy since it did not help the aesthetics in the area. He stated that Congressman Gosar at the time suggested that the County offer their own plan, and Supervisor D. L. Wilson drafted a plan; and now, a couple of years later, WAPA is planning a very similar plan to what the county proposed, by relocating the power lines away from the river area.

Chairman Minor stated that comments about the proposal are being accepted this week and a draft response preferring the "Jumper 7" option for the Bouse Upgrade is being supported in the County's response. He added that Mr. Wilson was present to answer any questions regarding the proposal.

CHAIRMAN MINOR MOVED to take an official position and to provide comments regarding the Western Area Power Administration (WAPA) Draft Environmental Assessment for the Bouse Upgrade Project, as presented (choosing Jumper 7 option). Motion seconded by Supervisor Plunkett, passed unanimously, including the vote by Vice-Chairman Irwin.

Discussion and possible action to go into Executive Session pursuant to A.R.S. §38-431.03(A)(3) to consult with the attorney(s) of the public body regarding code compliance issues in the County - County Attorney

CHAIRMAN MINOR MOVED to go into Executive Session pursuant to A.R.S. §38-431.03(A)(3) to consult with the attorney(s) of the public body regarding code compliance issues in the County. Motion seconded by Supervisor Plunkett.

Vice-Chairman Irwin asked why there was a need to go into executive session.

Supervisor Plunkett answered that the statute provides the Board with the ability to go into executive session, and has done so before for the purpose of obtaining legal advice on specific occasions.

MOTION PASSED unanimously, including the vote by Vice-Chairman Irwin.
